

## GEMINI next Generation

A century ago, purchasing power was very low compared to today, yet the share of housing costs in family income was much smaller than today.

Since the first climate conference in Rio in 1992, there has been constant talk of “more money for climate protection”, yet the results have been very modest, and the goal of net zero emissions completely inadequate.

“GEMINI” means twin in Latin, it stands since the first generation of the “GEMINI inhabited solar power plant” 1991 for “No better house, no better solar power plant possible on the same plot”, for the double use of a plot.

True climate protection is only possible with a higher standard of living, and this standard of living must be measured specifically among the poorest 20% of the population.

What if there were a house whose initial cost was less than that of a conventional house, where the expenditure on energy was transformed into income from the sale of energy? Where five times more energy is produced than is consumed by the residents themselves, including electric cars?

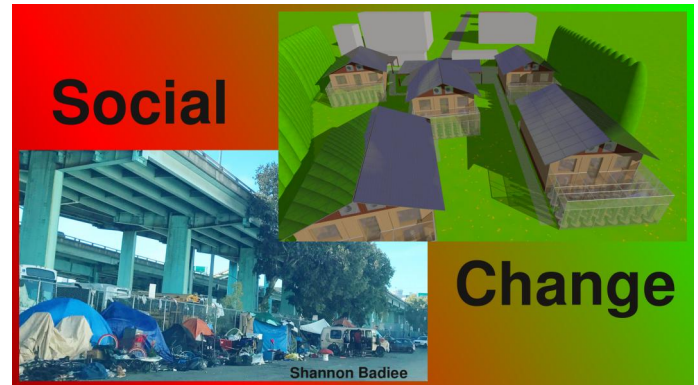
Then you would only need an affordable plot of land to realize the old dream of a house with its own garden. Loan installment minus energy sales revenue less than rent plus operating costs plus electricity bill plus fuel for the car.

The headline for the first draft of the investor documents 2019 was "We sell houses also to minimum pensioners". This stands for being able to provide a high standard of living with very low costs.

In the last decades many arguments have been built against this dream, but we can refute all of them.

What would happen if 80% of the land for the cultivation of biogas plants were returned to nature and 20% were converted into “land for energy”?

“Land for energy” stands for building land where only Climate Protection Superiority Houses may be built.



*Near to nature, family-friendly against the climate crisis: Real energy transition, “land for energy”, the barter of cheap building land for a lot of solar power, home ownership affordable for the richest 95% of the population.*

## Our vision

COP 46 2041 in Salzburg, the most important topics of the conference: Enforce building standard climate protection superiority house in all participating countries. Provide enough land in the “Land for Energy” program, as poverty alleviation and to generate more solar power.

Global production of Climate Protection Superiority House certified buildings will exceed 50 million units for the first time in 2041. By the end of 2041, an accumulation of 120 million will have been reached.

On these buildings are 6 TW photovoltaic with 7,500 TWh annual electricity production. Which market share will still hold the “GEMINI next Generation Inc.” as the first manufacturer of climate protection superiority houses? Maybe 20%, maybe 10%, but even only 1% would still be an annual turnover in the order of 50 billion.

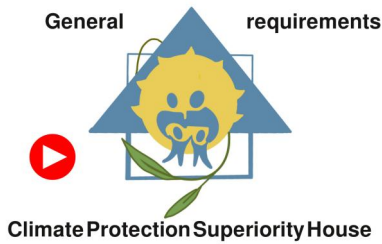

# A gamechanger for humanity



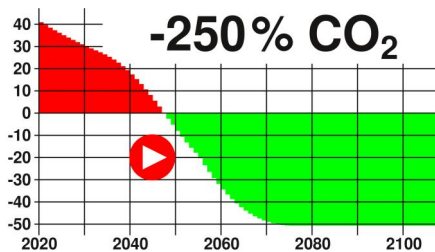
## Climate Protection Superiority House CPSH

An enduring civilization with respect and space for nature requires that housing, energy production and food production be combined in a space-saving way.



## The 1000 m<sup>2</sup> Civilization

More space for nature, more space for humans, stop wasting land through inefficient use, stop destroying nature for the nonsensically inefficient.



## -250% CO<sub>2</sub> emission until 350 ppm are reached again

Less CO<sub>2</sub> emission is much too little, even zero emission is insufficient. Only a planet renovation with large-scale CO<sub>2</sub> filtering and splitting from the atmosphere will help.

## The path to implementation

1991 Start of the project “GEMINI inhabited solar power plant”, the first GEMINI generation.

1993, 1994 Lots of honors up to the European Order of Merit, but no money.

2001 The “GEMINI House” becomes the main attraction of the Styrian Energy Exhibition in Weiz.

2011 “Land for Energy” concept introduced to politicians and prefabricated house producers.

2018 “Cheaper living” project is launched.

2019 The principles of the “GEMINI next Generation” house are developed, a model settlement with 5 houses is planned in Unken near Salzburg.

2020 First round of financing. Components of the technology for the house are purchased for the "proof of concept".

2021 Tests of the purchased components, 5 patents and 2 trademarks are prepared for registration.

Videos about the project, context and significance of the project are produced in English and German.

The search for employees and the planning for the equipment of the production hall begins.

2022 Foundation of GEMINI next Generation Inc. to create a structure for further investors:

70,000 minimum capital for a stock cooperation in Austria. As a special privilege, the initial investors receive an allocation certificate for 0.1% of future share issues for every € 2,000 they invest.

A team of freelancers prepares the capital increase to € 4 million in the autumn of 2022.

2023 A factory hall is built, technical equipment is purchased. The houses for the Unken model settlement are produced.

Main work is the videos and documentation of each step of production to give the most perfect guidance to new employees in new branches and DIY self-collectors.

2024 Opening ceremony of the first sample settlement in Unken with a huge surprise: patent 4 and 5 at work.

With the practical application of patent 4 and 5 publicly demonstrated, a capital increase into the 9-digit range begins, i.e. beyond €100 million.

2025 The first factory hall in full production, many new factory halls are built worldwide.

2026 Many factory halls worldwide in full production.
